Such purposes, in accordance to art. 5, comply with the law, they are reasonable and transparent, as well as specific, explicit and legitimate.

THE LEGITIMATE PURPOSES PURSUED BY THE CONTROLLER OF THE PROCESSING OF PERSONAL DATA

The controller of the processing will use data for the above mentioned purposes and he will pursue the contract signed by both parties.

RECIPIENTS OF PERSONAL DATA

«Recipient» means any natural person or legal entity, public authority, service or any other body who may receive personal data, wheather a third party or not.

The controller's intentions to transfer data to a third country or a corporate organisation.

The controller of personal data for the above mentioned purposes, cultural exchanges/ study abroad trips, has to transfer all those data which are necessary to perform activities even outside the European Community.

ACCESS TO DATA

All your personal data can only be accessed by employees duly trained and appointed with the right appointment letter. Paper copies are stored in specific archives divided in categories for each individual; "International Experience srl" trained its employees about the immediate communication of data wheather an individual asks for them.

In this sense, upon written request to the controller of the processing of personal data, even via email, interested parties can access their data to:

- -verify the truthfulness;
- -modify them if they're wrong;
- -submit them even with a supplementary statement;
- -ask for the cancellation.

The controller of personal data is obliged to respond without any unjustified reason.

DATA RETENTION

"International Experience srl" will preserve data kept in a form which permits the identification of data subjects for no longer than is necessary for the purposes for which the data have been processed.

Once reached the purposes of the processing of data necessary for tax obbligations, accounting and employment practices, data will be preserved for longer than 10 years and in accordance with art. 22 of DPR N.600/1973.

CANCELLATION OF DATA

In accordance with data subjects' right to access data, "International Experience srl" has adopted procedures for the subjects who are interested in the cancellation of personal data without undue delay or in the limitation of their personal data for the following reasons:

- -data are no longer necessary for the purposes of the processing;
- -the subject revoked his consent for the processing of data;
- -the subject objects to the processing;
- -data are processed illegally.

Further rights of the subject

- -Right to revoke the consent at any time without prejudicing the lawfulness of processing based on the consent given before the revocation;
- -right to lodge a complaint with the supervisory authority (art.13);
- subject's right to object to the processing of data at any time, including profiling, for reasons linked to his situation. The data controller refrains from processing personal data further unless he shows the existence of legitimate reasons mandatory to process data, prevailing on the interests, rights and freedom of the subject. (art.21)
- right to object to the processing of his data, if they're used for marketing reasons. After his objecting, data can no longer be processed for these reasons.
- -right to object to the processing of data for historical and scientific purposes unless public interest is prevailing. (art.21)
